# Children (Public Law)

---

Adam represents local authorities, parents, children and interveners on the most serious and complex cases.

## Selected Cases

- **Re : E (2019- 2022)**: Leading Junior in an extremely long running and complex case, hearing over 25 days, including appeal. Instructed by the local authority in which findings of sexual abuse, (involving transmission of HPV), and failure to protect made. Multiple experts with conflicting opinions.
- **Re FT (2020)**: Representing a very vulnerable mother with significant learning and communication needs in a tragic child death case in The High Court. Led By Alison Grief QC. Client wholly exonerated from responsibility for her babies' death, or any failure to protect.

## Children (Private Law)

---

Adam has significant experience in complex private law matters. These include private law cases involving allegations of implacable hostility, shared care arrangements, internal and external relocation, special guardianship and fact-finding hearings regarding domestic violence, sexual abuse and children giving evidence. Adam also acts for parents in section 8 Children Act 1989 applications, including those which feature non-compliance and enforcement, require a rule 16.4 guardian, involving permission to remove children from England and Wales, and where special guardianship orders are sought.

He has a reputation for compassion for his clients, and hard work and results.
