DIVERSITY DATA 2018

Our regulator, the Bar Standards Board (BSB), has introduced rules for the gathering and publication of diversity data. Chambers has appointed the Chambers Director to be its "Diversity Data Officer" and he conducted a survey in accordance with the survey questionnaire devised by the BSB (based on the model drafted by the Legal Services Board) during December 2018. The survey was voluntary and was carried out in such a way as to guarantee the anonymity of those who contributed to it. The summary of the data gathered in the survey in December 2018 is published below in accordance with the guidance set out in the relevant BSB rules.

Members, Pupils and Staff Numbers

Chambers Overall

Chambers overall had 25 silks, 100 juniors, 6 pupils and 29 staff.

London

London Chambers had 25 silks, 45 junior members, 3 pupils and 20 staff in London.

Brighton

Brighton Chambers had 55 junior members, 3 pupils and 9 staff in Brighton.

Response Rate

The overall response rate to the Data Diversity survey (which is entirely voluntary) was;

Silks – 64%

Junior Members and Pupils – 72%
