Clinical Negligence

Judith has extensive experience of advisory and advocacy work for both claimants and defendants, as well as a strong record of successfully resolving claims through ADR.

Her practice involves cases in a wide variety of disciplines including claims related to general practice, obstetrics and gynaecology, oncology, gastroenterology, orthopaedics, neurology and plastic surgery. She has acted in numerous high value catastrophic brain injury cases dealing with complicated issues of both liability and quantum, where she has been instructed both as junior counsel and alone, often appearing against leading counsel.

Her trial experience includes successfully defending claims alleging a failure by a nurse to properly manage glaucoma, a bowel perforation during a radical hysterectomy, negligence during surgery to correct spinal scoliosis resulting in paralysis and allegations against a Consultant Orthopaedic Surgeon concerning avascular necrosis of the hip.

In addition to substantive arguments relating to liability and quantum, Judith has wide experience of:

- Claims involving complicated issues relating to limitation.
- Allegations of interference with the rights conferred by Articles 2, 3 and 8 of the ECHR in the context of healthcare claims.
- Claims involving periodical payments. She was extensively involved in the finalisation of the many claims which had been on hold pending the conclusion of the proceedings in *Thompstone v Tameside Hospital NHS Foundation Trust* concerning the indexation of periodical payments.
- Procedural and interlocutory matters that often arise in clinical negligence litigation.

Professional Discipline & Regulation

Judith has appeared before Interim Orders panels and at Fitness to Practise hearings in a number of healthcare tribunals including the Medical Practitioners Tribunal Service, the General Dental Council and the Health and Care Professions Council. She has also been involved in internal Trust disciplinary proceedings and fitness to practise hearings concerning medical students.

Her experience includes representing practitioners during investigations related to performance, health and conduct, including cases arising from criminal convictions and allegations of dishonesty.

She also has a good track record of drafting lengthy written submissions to assist in the resolution of claims at the early stages of proceedings. Her most recent experience in this respect includes complaints against doctors, psychotherapists and psychologists.

Judith appeared alongside leading counsel on behalf a doctor facing proceedings in the lengthy Fitness to Practise hearing arising out of a clinical trial into the relationship between cardiac defects and migraine headaches and in the subsequent s.40 appeal before the High Court. Her experience also includes acting as junior counsel in a long running hearing concerning allegations made against a GP who had previously been tried in the criminal courts for sexual assault.

In addition to appearing in professional disciplinary tribunals, she has previously appeared in the Magistrates' and Crown Court on behalf of healthcare professionals facing criminal allegations arising out of their professional conduct.

During her second six months of pupillage Judith was appointed by the Council of the Inns of Court as a Clerk to the Bar Standards Board disciplinary tribunal. She continued in this role for seven years and was subsequently instructed as counsel for the BSB in proceedings before the Visitors to the Inns of Court. She therefore has extensive knowledge and experience of professional conduct and disciplinary proceedings at the Bar.

Inquests

Judith frequently appears in the Coroner's Court where she has represented families, clinicians and other interested parties and pre-inquest reviews and substantive hearings.

Her experience includes inquests following missed or late diagnoses, surgical complications and the sudden unexplained death of small children. She has been involved in a number of cases where there have been significant issues related to mental health care.

She has also appeared at inquests arising out of the unexpected deaths of individuals under the care of local authorities or the NHS, whilst in custody or as a result of accidents at work.

She has particular experience of representing clinicians and Ambulance Trusts at inquests arising from delays in responding to emergency calls and is familiar with the policy and resources issues which arise at such hearings.

Healthcare and Court of Protection

Early in her career Judith was instructed by Primary Care Trusts as junior counsel in judicial review proceedings relating to the closure of the maternity department of a hospital and as an interested party in proceedings seeking to challenge the Secretary of State for Health's approval of a major hospital rebuilding project in the North East of England.

She has represented NHS Trusts in judicial review proceedings, in claims seeking injunctive relief on behalf of hospital staff and in claims seeking declarations relating to the treatment of patients.

She has also been involved in proceedings brought by individual doctors seeking to challenge decisions made by the GMC.

Judith has been instructed in claims seeking declarations from the Court in respect of the treatment of patients in 'best interests' cases and where the Court has had to consider Deprivation of Liberty safeguards. Her experience includes cases relating to the administration or discontinuation of treatment and the issue of whether patients should remain in hospital or be discharged into alternative care. In addition she has advised in respect of the protection of the assets of individuals who lack capacity to manage their own affairs. She has made applications on behalf of hospital staff for injunctive relief under the Protection from Harassment Act 1997, including a number of such applications involving mental health issues.

She has also acted in possession proceedings on behalf of Trusts seeking to remove patients who have refused to leave hospital after the conclusion of their treatment.

Personal Injury

Judith has significant experience of advising and representing both claimants and defendants.

In addition to civil proceedings, she has appeared before the Criminal Injuries Compensation Appeal Panel on behalf of appellants who have been injured as a result of criminal acts.

In the early years of her practice she assisted the Treasury Solicitor's private law team in a number of claims,

including actions against the Prison Service, claims for stress at work and allegations of misfeasance in public office. She was also involved in claims against the Department for the Environment, Food and Rural Affairs and the Ministry of Defence.
